Upon motion by Danny Gaekwad, second by Leo Govoni, and unanimously carried by the directors present, the motion to adopt the attached resolution appointing Laura DiBella as President of Enterprise Florida and to serve as the Secretary of Commerce, was approved.

RESOLUTION OF THE BOARD OF DIRECTORS OF ENTERPRISE FLORIDA, INC.

- WHEREAS, Enterprise Florida, Inc. ("EFI") acts as the economic development organization for the state of Florida, utilizing private sector and public sector expertise to promote and attract economic development in Florida;
- WHEREAS, the EFI Board of Directors ("Board"), is required by section 288.905(1), Florida Statutes, to appoint a president, who shall serve at the pleasure of the Governor, be known as the "Secretary of Commerce", and who shall serve as the Governor's chief negotiator for business recruitment and expansion;
- WHEREAS, Governor Ron DeSantis, Chairman of the Board, has nominated Laura DiBella, the current Deputy Secretary of Commerce, to be appointed President of EFI and serve as the Secretary of Commerce;
- WHEREAS, the EFI president is the chief administrative and operational officer of the Board and EFI, and shall direct and supervise the administrative affairs of the Board and any divisions, councils, or boards thereof, section 288.905(2), Florida Statutes;
- WHEREAS, the EFI president has overall responsibility for the development, planning, and implementation of EFI's economic development program and goals in accordance with the directions and instructions of the Board;
- WHEREAS, the EFI president shall establish staff policies, participate in the preparation of annual budgets, engage the services of outside professionals as needed, and otherwise attend to the day-to-day operation of EFI and carry out the instructions of the Board; and
- WHEREAS, the Board may delegate to the president those powers and responsibilities it deems appropriate, including hiring and management of all staff, except for the appointment of a president, section 288.905(2), Florida Statutes.
- **NOW THEREFORE,** in accordance with the Board's powers and duties vested by the laws of the State of Florida, and the EFI governing documents, it is hereby:

RESOLVED: that,

- 1. Governor Ron DeSantis' nominee, Laura DiBella, is hereby appointed President of EFI, shall serve as the Secretary of Commerce, and is designated Secretary of EFI pursuant to the EFI governing documents;
- 2. The President shall have the authority to hire and terminate all EFI employees and to determine their compensation within approved budget limitations;
- 3. The President is authorized and empowered, in the name of and on behalf of the Board, to make expenditures and enter into contracts and other instruments necessary or convenient for the exercise of the Board's powers

and functions in accordance with approved purchasing policies and within approved budget limitations;

- 4. The President is authorized to exercise all other authority granted under the EFI governing documents and Florida law, and such other powers and responsibilities delegated by the Board; and
- 5. The Vice Chairperson, Holly Borgmann, is hereby delegated authority and instructed to negotiate the terms of the President's employment contract and execute the same on behalf of the Board.

Born and raised in Joliet, Illinois, Robert, and his wife Debra reside in Palm Beach Gardens, Florida.






Mitchel Laskey CFO and Managing Director

Enterprise Florida March 2023 Board of Directors Financial Narrative

<u>Revenue:</u>

- YTD revenue was \$12.6M, exceeding the YTD revenue budget by 10%.
- State revenue for our military and defense programs has been received on an accelerated schedule due to when we incurred expenses. Enterprise Florida is reimbursed for these expenses throughout the year, up to the annual \$2M appropriation.
- Event revenue is exceeding the YTD budget due to the timing of payments and events.
- Other revenue is exceeding our YTD budget due to interest income generated through our Wells Fargo sweep accounts. EFI did not budget for interest income and, as experienced by many, bank interest rates have increased throughout the year.
- We anticipate the excess revenue from the state and events to even out during the next quarter and are not anticipating an excess in these categories at year-end.
- Private revenue is below the YTD budget due to decreased revenue from board memberships. Payment timing and membership losses have resulted in missing revenue expectations. One win in this category is the Team Florida board, which has almost tripled YTD planned revenue.
- Management fee revenue is below budget as anticipated. The original budget included \$50K in additional FOF management fees. These fees were not approved by the FOF Board and will be revisited as part of FY2023-2024 planning.
- We anticipate private revenue and management fees ending the year below budget.
- Looking ahead, revenue at fiscal year end is projected to exceed the annual budget by \$200K due to selfgenerated revenue.

Expenses:

- YTD expenses, including program expenses, totaled \$13.8M. When adjusted for outstanding \$5M FIFA commitment, we are essentially on track with expectations and exceeded planned YTD expenses by only \$12K.
- Program expenses (adjusted for FIFA) exceeded the YTD budget by approximately \$800K (14%). The bulk of the excess is associated with the timing of Military and Defense program expenses. These expenses resulted in receiving M&D state funds earlier than expected. Marketing and Team Florida expenses have exceeded the YTD budget by \$16K. General program expenses are \$154K higher than planned due to demand for services and stakeholder support.

- We anticipate the overage in M&D program expenses to even out by year-end. General program expenses are projected to end the year approximately \$170K higher than the planned budget due to continuous demand and need.
- Personnel, travel, marketing, and rent expenses are below the YTD budget. Position vacancies have resulted in a YTD personnel savings. Travel is down due to leadership focus on ensuring general business travel is essential. Most of our marketing expenses have been charged to program expense, thus the YTD savings in general marketing expense.
- We anticipate a portion of the YTD personnel savings to carry forward to year-end and are projecting approximately \$111K in savings within this category. Included in our projection is an increased investment in our benefits program. Travel is also projected to end the year under budget by approximately \$160K. Year-end savings from Marketing are not currently anticipated but is pending potential initiatives during Q4.
- Professional fees exceeded the YTD budget by approximately \$230K due to an expense originally planned during the prior year (\$150K), contractors, and business intelligence services. We anticipate the overage in this line to continue throughout the year, ending the year \$290K over budget.
- Overhead expenses exceeded the YTD budget by approximately \$66K due to increased telecommunications charges and increased stakeholder support via organizational memberships. We anticipate these overages continuing throughout the year and project this line will be \$141K over budget at year-end.
- Looking ahead, we anticipate ending the year \$196K under the planned expense budget. Savings in travel and personnel are projected to mitigate the impact of overages in other categories, allowing us to redirect resources to where they are needed.

<u>General:</u>

- Enterprise Florida is projected to end the year as originally planned due to increased revenue balancing the projected increase in expenses. Adjusted for FIFA, our net income at year-end is projected to be -\$3.1M, consistent with the approved budget.
- The negative net income was purposely planned due to the need for Enterprise Florida to utilize cash received in prior fiscal years. These resources were entrusted in the organization to invest in economic development and commerce initiatives, and we are strategically activating prior year resources for their intended purpose.
- Inclusive of FIFA, we anticipate utilizing approximately \$8.3M in prior year resources in our current fiscal year.
- Overall, the organization has done well at managing the resources entrusted to us, and pivoting where required to ensure we end the year within the bounds of our approved net income.
