Scope: the scope of this contract was to provide consulting services in support of beddown of the MQ-9 Wing at Tyndall AFB, to participate in the development of the Tyndall 2030 plan, and foster an increase in community partnerships. However, once Hurricane Michael struck Tyndall AFB and Bay County on 10 October 2018 the focus of the contract efforts changed. Beginning on 11 Octour focus areas were to work with AF and Congress to keep Tyndall open, to advocate with Congress for supplemental funding for Air Force to enable rebuild of Tyndall AFB, to ensure Tyndall was rebuilt "base of the future", to work to ensure new mission beddown stayed on track – F35's and MQ-9 Wing and finally to leverage community partnership opportunities, as it made sense, post-Hurricane Michael.
