Final Report in Support of CON 19-05 Gulf Coast State College and The Roosevelt Group Tyndall AFB: Resiliency/Mission Return/"Base of the Future" 20 April 2020

Scope:

Tyndall Air Force Base suffered tremendous and catastrophic damage during Hurricane Michael on October 10, 2018. Tyndall AFB's mission is directly correlated with state ROI due to its more than \$2.5 billion annual impact to the local and state economy and its missions provide irreplaceable military value. Base recovery is essential to its future and the potential MQ-9 mission bringing 1,600 jobs and effort to bring three squadrons of F-35s to replace the F-22 operational squadron displaced by Hurricane Michael.

It is essential to the State of Florida that recovery efforts ensure the return of missions remain on track to maintain Tyndall AFB's robust military value. Bay County understood they needed to remain proactive to ensure that all prestorm missions return to the base and to identify the funding requirements needed to rebuild and to assist the Air Force in building the premier "Base of the Future" at Tyndall Air Force Base. This scope of this efforts ensures for strategic coordination of local, state, and federal leadership to ensure mission return.
