Executive Summary

Created in 2011 under Florida Statute 288.987, the Florida Defense Support Task Force (FDSTF) held its first meetings in January 2011. The task force has 13 members – four members appointed by the Governor, four members appointed by the Senate, and four members appointed by the House of Representatives. The Governor has designated Representative Dana Young as the 13th member and his representative on the Task Force. The Task Force chairmanship passed from House Appointee Representative Ritch Workman to Senate Appointee, Representative Jimmy Patronis in January 2013. Dr. David Goetsch continues to serve as the Vice Chair.

The FDSTF mission is to make recommendations to preserve and protect military installations, to support the state's position in research and development related to or arising out of military missions and contracting, and to improve the state's military-friendly environment for service members, military dependents, military retirees, and businesses that bring military and base-related jobs to the state.

The FDSTF replaced the Florida Council on Military Bases and Mission Support which was created under Florida Statute 288.984. The Council has been deleted from Florida Statute. The FDSTF received an FY 2011-2012 appropriation of \$5 million, a FY 2012 –13 appropriation of \$2 million, and an FY 2013-2014 appropriation of \$4 million to protect, preserve, promote and grow Florida military installations and missions. The Task Force held a total of 11 meetings throughout the calendar year 2013.

The Task Force provides weekly email updates for its members. The Task Force developed an initial strategic plan to guide its actions in protecting Florida's military installations dated April 23, 2012. This plan was updated in October 2012 and again in July 2013. This updated version of the strategic plan is posted on the Task Force web site, and at Tab C.

The Task Force finished publication and distribution of a 2013 Florida Defense Factbook based on the Florida Defense Industry Economic Impact Analysis compiled by the University of West Florida Haas Center. A copy is enclosed at Tab M.

Florida Defense Support Task Force web site has been operational since August 2012. It has been helpful in publicizing meeting times and locations. Additionally, this site displays the award of funding grants along with copies of agenda and minutes from Task Force meetings, budget information and weekly Task Force updates. The web site is:

The Task Force published the 2013 Florida Military Friendly Guide in October 2013. It contains a summary of the Florida laws that benefit active duty, National Guard and Reserve service members and their families. This guide has been distributed throughout the state and to the Florida Congressional delegation. It can be downloaded from the Task Force web site. A copy is enclosed at Tab L.

Governing Florida Statutes

The Florida Defense Support Task Force was established under Florida Statute 288.987 and operates under a Sunshine exemption in F.S. 288.985. See Tab A.

Appointments

In 2013, Representative Jimmy Patronis was appointed as the Task Force Chairman. Representative Dana Young was appointed by Governor Scott as his personal representative on the Task Force. See Tab B.

Funding

The FDSTF received an FY 2013-2014 appropriation of \$4 million to protect, preserve, promote and grow Florida military installations and missions. The Task Force may annually utilize up to \$200,000 of funds appropriated to the Department of Economic Opportunity for Task Force staffing and administrative expenses. Enterprise Florida, Inc. (EFI) has the role of administrative and logistical support. Task Force budget summary, 2014 contract obligations and FY 12-13 administrative expenses is included at the end of this report. See Tab J.

Task Force Reports

The Task Force is required to submit an annual report and work plan to the Governor, the President of the Senate, and the Speaker of the House of Representatives by February 1st of each year.

Task Force Strategic Plan

The Task Force actions are guided by its Strategic Plan. This plan is a living document and evolves in response to unfolding events. This plan was first developed in April 2012 and has been updated twice – once in October 2012 and then again in July 2013. The revised version adjusts the Task Force goals to reflect the changing national defense budgets and its impact on Florida's military missions and installations. See Tab C.

Task Force Meetings

January 17, 2013 -- Tallahassee. Task Force members approved the 2012 Annual Report. Staff provided a budget update on the status of Task Force funds. The Task Force considered 15 applications for FY 2013 funding based on the published Funding Application Process. (See Tab D) After reviewing written applications and receiving in-person presentations from applicants, the Task Force decided to fund 10 projects for FY 2013. The projects totaled \$2.65 million. The grant recipients included National Center for Simulation in Orlando, Greater Pensacola Chamber, Santa Rosa County, Highland County Economic Development Council, the City of Jacksonville, Tampa Bay Defense Alliance, Bay Defense Alliance, Florida 8 (a) Alliance, and the Andrews Institute. The FY 2013 grant announcement is included at Tab E. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida.

February 21, 2013 -- Tallahassee.

The Task Force received an update from The Principi Group concerning DOD budget cuts and sequestration along with their projected impacts to Florida. Staff provided a budget update on the status of Task Force funds. Jim Kuzma from Space Florida provided an update on Unmanned Aerial Vehicles (UAV) and Florida's efforts to become one of six test sites in the nation. The decision on sites is due by December 31, 2013. The Task Force received a briefing on a draft Task Force budget for FY 2013-2014. Staff presented a compilation of 17 military or veteran-related bills moving through committees in the state legislature. The Task Force directed staff to develop a pamphlet containing all the existing state laws providing benefits to military members and families stationed in Florida. This guide would cover active duty, Reserve and National Guard service members and families. Dr. Rod Lewis from the University of West Florida Haas Center presented the 2013 Florida Defense Factbook and was commended on an outstanding publication. The Task Force also received updates from The Nature Conservancy and the Florida League of Defense Contractors.

March 21, 2013 -- Tallahassee.

Staff provided the Task Force of a draft pamphlet containing all the existing state laws providing benefits to military members and families stationed in Florida. The Task Force approved moving forward to publish this pamphlet after the legislative session. A budget update on the status of Task Force funds was provided. Maj Gen Titshaw briefed the Task Force on the impacts sequestration and the Continuing Resolution might have on the Florida National Guard. Staff briefed on legislative bills impacting military members and veterans. Notably, a proposed bill to establish a non-conservation land base buffering program -- built into the Military Base Protection Program -- would help strengthen Florida's installations against encroachment. The Task Force received an update from The Principi Group on current military and defense issues in Washington and their impact on Florida. The Task Force conducted an afternoon closed session meeting to discuss advocacy strategy involving base strengths and weaknesses connected to protecting, preserving and enhancing Florida's military installations.

April 18, 2013 -- Tallahassee

The Task Force welcomed Representative Dana Young to the Task Force as the Governor's Personal Representative replacing former Lieutenant Governor Carroll. Staff provided a budget update on the status of Task Force funds along with a status report on FY 2013 grant contracts. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. Over the next year, The Principi Group will visit military communities and installations in conjunction with Task Force meetings. The intent of these re-visits is to receive updated information on issues impacting every Florida installation in order to provide better and more informed advocacy. Staff presented an update on state bills moving through the Legislature. Executive Director Mike Prendergast from the Florida Department of Veterans Affairs provided a status report on proposed bills moving through the state Legislature affecting veterans and answered questions from the Task Force. Susan Grandin, Director of State Lands, Department of Environmental Protection, briefed on the state land acquisition process and conservation lands buffering military installations. Mike McDaniel followed with a briefing on the acquisition of non-conservation buffering lands outside military

installations in the state. The Task Force directed staff to develop a one-page highlight of Task Force successes over the past year. (See Tab H)

May 16, 2013 – Panama City Beach

The Bay County Defense Alliance welcomed the Task Force and provided a brief update on their activities. Staff provided a budget update on the status of Task Force funds and the FY 2013 grant awards. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. Staff summarized military-related legislation passed during the session. Steve Murray from the Florida Department of Veterans Affairs briefed the Task Force on all veteran-related legislation passed and did not pass during the recent legislative session. The Task Force conducted an afternoon closed session meeting to discuss advocacy strategy involving base strengths and weaknesses connected to protecting, preserving and enhancing Florida's military installations. Following the meeting, Task Force members received a tour of NSA Panama City.

June 27, 2013 – Tampa

The Tampa Bay Defense Alliance welcomed the Task Force and provided a brief update on their activities. Staff provided a budget update on the status of Task Force funds and the FY 2013 grant awards. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. LtGen (Ret) Gordon Fornell, USAF briefed the Task Force on public private partnership successes at Eglin AFB and proposals to expand the program statewide. MG (Ret) Joseph Taluto briefed on the Veterans Pathway to Success program and LtCol Paul Niedhardt briefed on the capabilities of Avon Park Air Force Range. The Task Force conducted an afternoon closed session meeting to discuss advocacy strategy involving base strengths and weaknesses connected to protecting, preserving and enhancing Florida's military installations. Following the meeting, Task Force members received a tour of MacDill AFB and a briefing from the Chief of Staff, US Central Command.

July 18, 2013 – St. Augustine

MajGen Titshaw welcomed the Task Force to St. Francis Barracks and St. Augustine. He gave a thorough briefing on the Florida National Guard that covered their capabilities and challenges. Staff provided a budget update on the status of Task Force funds and the FY 2013 grant awards. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. Staff described a list of military-related bills that might arise during the next session. The Task Force reviewed an updated version of the Task Force Strategic Plan that was later approved and dated July 19, 2013. (See Tab C) Staff briefed on the guidelines for the FY 2014 Grant Funding Process released last week. The deadline for submitting applications is August 29, 2013. The Task Force will review the applications, receive in-person presentations and decide on the grants at the next meeting in September. The Task Force conducted an afternoon closed session meeting to discuss advocacy strategy involving base strengths and weaknesses connected to protecting, preserving and enhancing Florida's

military installations. Following the meeting, Task Force members received a tour of St. Francis Barracks from LTC (Ret) Greg Moore, the Florida National Guard Historian.

September 19, 2013 – Tallahassee

Staff provided a budget update on the status of Task Force funds and the FY 2013 grant awards. Ms. Colleen Krepstekies from the Florida Department of Veterans Affairs provided nationwide and state updates on veterans' in-state tuition initiatives. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. Staff described a list of military-related bills that have been filed in the state Legislature. Ana Richmond from the Department of Economic Opportunity provided an update on the progress of implementation of the non-conservation encroachment buffering program. The Task Force approved drafting a letter supporting the acquisition priorities briefed by Ms. Richmond. (See Tab I) Susan Grandin, Director of State Lands, Department of Environmental Protection, made a presentation on acquiring conservation properties across the state that buffer military installations. Jim Kuzma briefed the Task Force on an initiative to commercialize the Eastern Range. The Task Force considered 12 applications for FY 2014 funding based on the published FY 2014 Grant Application Process. (Tab F) After reviewing written applications and receiving in-person presentations from applicants, the Task Force decided to fund 7 projects for FY 2014 and fence funding to request 3 additional projects for possible award of funding at a later date pending additional details. The projects totaled \$2.47 million. The grant recipients included National Center for Simulation in Orlando, Clay County Development Authority (2), City of Niceville, Greater Pensacola Chamber, Tampa Bay Defense Alliance, and the Economic Development Alliance of Bay County. The Economic Development Council of Okaloosa County, the Miami-Dade Defense Alliance and the Florida 8 (a) Alliance are the three fenced applicants. The FY 2014 grant announcement is included at Tab G.

November 21, 2013 – Jacksonville

The City of Jacksonville welcomed the Task Force to Jacksonville. Staff provided a budget update on the status of Task Force funds and the FY 2013 grant awards. Doug Callaway, the new Director of the State of Florida Washington Office introduced himself and briefed the Task Force on current issues in Washington, DC. The Task Force received an update from the Principi Group on current military and defense issues in Washington and their impact on Florida. Staff provided an update on legislative issues. Jim Breitenfeld from Okaloosa County briefed the Task Force on the grant application from the Economic Development Committee of Okaloosa County. The Task Force approved the application for \$195,000 to develop a public-private partnership program at Eglin AFB that can be replicated statewide. Diana Gonzalez from the Miami Dade Defense Alliance briefed on their grant application to develop a community advocacy plan. The Task Force directed her to re-write her application and return with a stronger proposal. Staff briefed the Task Force on a proposal for Task Force attendance/representation at certain military conferences throughout 2014. The Task Force directed staff to modify the plan, develop clear objectives for each and present a modified plan at the next meeting.

The Task Force conducted an afternoon closed session meeting to discuss advocacy strategy involving base strengths and weaknesses connected to protecting, preserving and enhancing Florida's military installations. Following the meeting, Task Force members received a tour Naval Station Mayport and the USS Vicksburg.

December 10, 2013 – Conference Call Meeting

The Task Force met in closed session via a conference call to discuss the terms of the contract renewal for The Principi Group. The Task Force agreed to support a new contract for advocacy along with a revised scope of work with the contract extension running from January 2014 through December 2015, and funded at the rate of \$75,000 per month.

December 27, 2013 – Conference Call Meeting

The Task Force met in open session via a conference call to discuss the terms of the contract renewal for The Principi Group. The Task Force agreed to support a new contract for advocacy along with a revised scope of work. The new contract will run from January 2014 through December 2015.

Activities/Achievements

Task Force's activities and achievements for 2013 include:

1. New Task Force Chair, Representative Jimmy Patronis assumed duties in January 2013. Dr. David Goetsch continued to serve as the Vice Chair.
2. The Task Force completed two rounds of grant awards. The 10 FY 2013 grants awarded totaled \$2.65 million and announced in January 2013. For FY 2014, 7 grants were awarded in October 2013 for a total of \$2.47 million.
3. The Florida Defense Support Task Force maintains an updated web site: www.eflorida.com/floriddefense
4. The Principi Group conducted visits to military installations in conjunction with Task Force meetings. The purpose of the visits was to update the assessments made in 2012 and remain current on issues faced by each installation commander. During these visits, the installation commanders met with members of the Principi Group and Task Force staff. In this way, the installation commanders were able to provide information concerning issues directly to those advocating for Florida at the national level. Additionally, the Principi Group members met with local defense leaders to receive their community input.
5. The Principi Group continues their advocacy efforts throughout 2013. They provided monthly reports to the Task Force on their activities on behalf of Florida. Additionally, they participated in a weekly conference call that included Task Force staff, the state of Florida Washington office, and the Department of Military Affairs.
6. The Task Force published the 2013 Florida Defense Factbook based on the Florida Defense Industry Economic Impact Analysis conducted by the University of West Florida Haas Center. See Tab M.
7. The Task Force updates its strategic plan effective July 19, 2013. See Tab C.
8. The Task Force publishes and distributes the Florida Military Friendly Guide summarizing programs and benefits for active duty, National Guard and Reserve service members and families. An electronic version of the guide is available on the Task Force web site. See Tab L.

State Legislative Issues

The 2013 Florida legislative session initiated several actions which affected the statutory mission of the Task Force. Below is a listing of legislation initiated or supported by the Florida Defense Support Task Force that passed the Florida Legislature and was signed into law by Governor Scott:

Interstate Compact for Military Children - HB 7003 Relating to Interstate Compact on Educational Opportunity for Military Children

This bill abrogates future repeal of compact and provides for payment of annual dues.

Non-Conservation Base Buffering - SB 1784 Relating to Military Installations

This bill authorizes DEO to annually submit list of non-conservation lands which may be acquired for the purpose of buffering military bases from encroachment.

Allows for Late Voter Registration for Deployed Military Members - HB 7013 Relating to Florida Election Code. This bill revises persons authorized to register late to vote to include recently returned deployed service members.

FDSTF Community Grants -- Funding Application Process

The Task Force decided that within budget constraints, they may fund local initiatives that can be leveraged to promote, preserve, or enhance military missions and installations in Florida. The funding process will be a simplified one based on two criteria: The mission of the FDSTF as described in F.S. 288.987, and the FDSTF goals as stated in the FDSTF Strategic Plan, dated October 25, 2012.

In order to be eligible to receive funding, applicants for FDSTF project consideration must first obtain the support of a Task Force member as a project sponsor. The applicant must submit a FDSTF Project Application along with a budget and plan of action. When scheduled, the applicant will present the project proposal to the full Task Force for review and consideration. Approval requires a majority vote of eligible FDSTF members. State legislators are not eligible to vote on such matters. This entire process is posted on the Task Force web site.

The Task Force conducted two separate grant cycles during this calendar year –FY 2013 and FY 2014:

FY 2013 – In January, the Task Force considered 15 applications for FY 2013 funding. After reviewing written applications and receiving in-person presentations from applicants, the Task Force decided to fund 10 projects for FY 2013. The projects totaled \$2.65 million. The grant recipients included National Center for Simulation in Orlando, Greater Pensacola Chamber, Santa Rosa County, Highland County Economic Development Council, the City of Jacksonville, Tampa Bay Defense Alliance, Bay Defense Alliance, Florida 8 (a) Alliance, and the Andrews Institute. The FY 2013 grant process is included at Tab D and the announcement is included at Tab E.

FY 2014 – In September, the Task Force considered 12 applications for FY 2014 funding. After reviewing written applications and receiving in-person presentations from applicants, the Task Force decided to fund 7 projects for FY 2014 and fence funding requests for 3 additional projects for possible award of funding at a later date pending additional details. The projects totaled \$2.47 million. The grant recipients included National Center for Simulation in Orlando, Clay County Development Authority (2), City of Niceville, Greater Pensacola Chamber, Tampa Bay Defense Alliance, and the Economic Development Alliance of Bay County. The Economic Development Council of Okaloosa County, the Miami-Dade Defense Alliance and the Florida 8 (a) Alliance are the three fenced applicants. The FY 2014 grant process is included at Tab F and the announcement is included at Tab G.

Community Outreach Success – The Andrews Institute Eagle Fund

In 2013, the Task Force provided a grant award for \$225,000 to The Andrews Institute in Gulf Breeze to provide rehabilitation for 50 wounded special operations service members. This program supports wounded and injured military service men and women from the United States Special Operations Community in their pursuit to return to active duty. It provides fast access to best in class restoration, training, and education and is a fully integrated approach to healing and restoration delivered by a multidisciplinary team of specialists. This intensive focus provides each wounded/injured warrior with a great opportunity to extend their careers while increasing their quality of life. The service members sponsored by the Task Force have succeeded in their rehabilitation and returned to their units in Florida and across the nation. This program has provided a tremendous benefit to the community and the state of Florida. Because of this success funded by the Florida Defense Support Task Force, the United States Special Operations Command has expanded the program to include many more wounded special operations warriors from across the country.

FDSTF 2014 Work Plan

Work Plan for 2014

During 2014, the Task Force will work with The Principi Group, the Florida Congressional delegation, state government and local defense communities to aggressively advocate promoting and growing Florida's military installations based on the Task Force Strategic Plan. This plan was developed based on the results and recommendations from the comprehensive analysis and risk assessment conducted by The Spectrum Group of every military installation in Florida. Additionally, the Task Force will consider another round of funding initiatives that assist in supporting and protecting military installations.

The Task Force will meet on the third Thursday of every month throughout 2014. When possible, meetings will be held in various locations around the state and may include base visitations.

First Quarter

January – March 2014

- The Task Force will review and approve the Annual Report for submission to the Governor and Legislature.
- Task Force will discuss a 2014 budget recommendations for submission to the Florida Legislature.
- Task Force will monitor progress on legislative initiatives that support the Task Force mission.
- The Task Force will monitor state agency activities to prevent installation encroachment, improve transportation access, and enhance energy efficiency on military installations to meet DOD energy efficiency requirements.

Second Quarter

April – June 2014

- Task Force will review and monitor progress on federal, state and local military and defense issues, and make recommendations to the Governor and Legislature.
- The Task Force will update the Florida Military Friendly Guide to include successful military-related legislation passed during the 2014 session.
- Task Force will develop guidelines for FY 2015 Task Force Grants Funding Application Process for release in July.

Third Quarter

July – September 2014

- The Task Force will prepare a budget and legislative slate for 2015. They will identify the fiscal resources needed to support and implement FDSTF recommendations to further prepare for any future realignment or closures, or budget initiatives.
- The Task Force will also review and consider annual grant requests for additional financial resource support to local and regional governments to enhance their efforts to protect local defense installations.

Fourth Quarter

October – December 2014

- The Task Force will announce annual grant awards.
- The Task Force will refine evolving budget and legislative issues.

TAB A Florida Statute 288.987 / 288.985

288.987 Florida Defense Support Task Force.—

- (1) The Florida Defense Support Task Force is created.
- (2) The mission of the task force is to make recommendations to preserve and protect military installations to support the state's position in research and development related to or arising out of military missions and contracting, and to improve the state's military-friendly environment for service members, military dependents, military retirees, and businesses that bring military and base-related jobs to the state.
- (3) The task force shall be comprised of the Governor or his or her designee, and 12 members appointed as follows:
 - (a) Four members appointed by the Governor.
 - (b) Four members appointed by the President of the Senate.
 - (c) Four members appointed by the Speaker of the House of Representatives.
 - (d) Appointed members must represent defense-related industries or communities that host military bases and installations. All appointments must be made by August 1, 2011. Members shall serve for a term of 4 years, with the first term ending July 1, 2015. However, if members of the Legislature are appointed to the task force, those members shall serve until the expiration of their legislative term and may be reappointed once. A vacancy shall be filled for the remainder of the unexpired term in the same manner as the initial appointment. All members of the council are eligible for reappointment. A member who serves in the Legislature may participate in all task force activities but may only vote on matters that are advisory.
- (4) The President of the Senate and the Speaker of the House of Representatives shall each designate one of their appointees to serve as chair of the task force. The chair shall rotate each July 1. The appointee designated by the President of the Senate shall serve as initial chair. If the Governor, instead of his or her designee, participates in the activities of the task force, then the Governor shall serve as chair.
- (5) The executive director of the Department of Economic Opportunity, or his or her designee, shall serve as the ex officio, nonvoting executive director of the task force.
- (6) The task force shall submit an annual progress report and work plan to the Governor, the President of the Senate, and the Speaker of the House of Representatives each February 1.
- (7) The department shall contract with the task force for expenditure of appropriated funds, which may be used by the task force for economic and product research and development, joint planning with host communities to accommodate military missions and prevent base encroachment, advocacy on the state's behalf with federal civilian and military officials, assistance to school districts in providing a smooth transition for large numbers of additional military-related students, job training and placement for military spouses in communities with high proportions of active duty military personnel, and promotion of the state to military and related contractors and employers. The task force may annually spend up to \$200,000 of funds appropriated to the department for the task force for staffing and administrative expenses of the task force, including travel and per diem costs incurred by task force members who are not otherwise eligible for state reimbursement.

288.985 Exemptions from public records and public meetings requirements.—

(1) The following records held by the Florida Defense Support Task Force are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution:

(a) That portion of a record which relates to strengths and weaknesses of military installations or military missions in this state relative to the selection criteria for the realignment and closure of military bases and missions under any United States Department of Defense base realignment and closure process.

(b) That portion of a record which relates to strengths and weaknesses of military installations or military missions in other states or territories and the vulnerability of such installations or missions to base realignment or closure under the United States Department of Defense base realignment and closure process, and any agreements or proposals to relocate or realign military units and missions from other states or territories.

(c) That portion of a record which relates to the state's strategy to retain its military bases during any United States Department of Defense base realignment and closure process and any agreements or proposals to relocate or realign military units and missions.

(2) Meetings or portions of meetings of the Florida Defense Support Task Force, or a workgroup of the task force, at which records are presented or discussed which are exempt under subsection (1) are exempt from s. 286.011 and s. 24(b), Art. I of the State Constitution.

(3) Any records generated during those portions of meetings which are closed to the public under subsection (2), including, but not limited to, minutes, tape recordings, videotapes, digital recordings, transcriptions, or notes, are exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution.

(4) Any person who willfully and knowingly violates this section commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

(5) This section is subject to the Open Government Sunset Review Act in accordance with s. 119.15 and shall stand repealed on October 2, 2014, unless reviewed and saved from repeal through reenactment by the Legislature.

Vision

The Florida Defense Support Task Force will be an aggressive and effective advocate to promote, preserve, protect and expand military missions and installations across the state of Florida.

Guiding Principles

- Champion Florida as the “Most Military-Friendly State” in the nation.
- Advocate for favorable resolution of military and defense issues from a statewide perspective and unify Florida’s defense communities with one voice. Provide a plan for active and effective advocacy for military and homeland defense missions and facilities located in Florida including the United States Coast Guard.
- Promote Florida’s military friendly atmosphere and optimum training environment and locations as the best and most cost-effective alternative for the Department of Defense.

- Enhance the Florida Congressional Delegation efforts in working defense and security issues at the federal level.

- Focus on advocacy efforts to obtain results which are mutually beneficial to Florida and the defense community.
- Identify the military value of Florida installations using core Department of Defense criteria and the results of previous data calls.
- Assist the Governor’s office in addressing and supporting the needs of Florida’s installations identified as the result of base commander’s meetings.
- Champion and continue legacy of Florida’s warmth, embrace and respect for military family quality of life.

General Definitions

Defense is a multi-dimensional environment defined broadly to include the active service members, National Guard and Reserve forces, military dependents, military retirees and military-related businesses in the state of Florida.

Military installations include all bases, ranges and airspace within Florida and in waters adjacent to Florida.

Time Frame Definitions

Short term – The period in which the military services budget-driven realignments occur outside of a formal Base Realignment and Closure (BRAC) process.

The Florida Defense Support Task Force met on January 17, 2013 to consider funding applications for projects that would accomplish the mission of the Task Force and support the goals outlined in the Task Force Strategic Plan. All applications met these two initial criteria. Following thorough and careful review of the sixteen applications submitted for funding from the Florida Defense Support Task Force for FY 2013, the Task Force approved the ten applicants listed below to receive grant awards.

The Task Force members thoroughly reviewed the written proposals and then allowed the applicants to make in-person presentations to the Task Force at the January meeting. The Task Force members scored the proposals based on the following considerations:

1. Preserve, protect and enhance the base
2. Leverage other funding
3. Potential to improve military value
4. Evaluator judgment of the project

The Task Force methodology was to score each proposal on a scale of 0 – 40 points and then arrive at an average score for each. Using this prioritization and ranking, the Task Force then funded as many projects as possible while still preserving some funding for unforeseen contingencies. Guidance to Applicants

- A. Applicants must obtain support of a FDSTF member as a project sponsor. Once support is obtained, the applicant may submit funding application directly to FDSTF Executive Director via email.
- B. The Executive Director will notify the applicant to appear at the September 19, 2013 FDSTF meeting to make an in-person presentation.
- E. Presentations will include the proposal, clear support of the criteria listed above, details of the project, funding requested, expected return on investment and clearly defined, measurable outcomes in support of the Task Force mission.
- C. Presentations are limited to a maximum of 15 minutes.
- D. Upon conclusion of the presentations, the FDSTF members may render decisions concerning approval and grant amount. Approval requires a majority vote of eligible FDSTF members.
- E. Grants will be announced as soon as possible by the Governor.

Florida Defense Support Task Force – First Year Successes

Created under Florida Statute 288.987, the thirteen-member Florida Defense Support Task Force (FDSTF) has the mission to make recommendations to preserve and protect military installations, support the state's position in research and development related to or arising out of military missions and contracting, and improve the state's military-friendly environment for service members, military dependents, military retirees, and businesses that bring military and base-related jobs to the state. Successes 2012 – 2013:

1. Organized as a Task Force and conducted 10 meetings during the first year.
2. Developed and implemented a long range strategic plan to guide Task Force actions to protect, preserve and enhance Florida's military installations.
3. Completed comprehensive evaluation of the military value of all military installations. The Spectrum Group conducted this assessment and simultaneously conducted risk assessment of all bases in regard to possible realignment or closure.
4. Contracted with The Principi Group to advocate in Washington, DC on behalf of Florida's military installations. Their advocacy is accomplished in conjunction with the Florida Congressional delegation and the Governor's Washington office. The Principi Group has provided tremendous assistance to Florida's local defense communities during their annual visits to Washington. Most importantly, The Principi Group has been effective in the Pentagon and on Capitol Hill in gaining visibility on Florida's military and defense issues.
5. Published 2013 "Florida Defense Industry Economic Impact Analysis" and the resultant Florida Defense Factbook and other marketing materials to educate and raise awareness of the economic impact of the military presence and defense industry to Florida's economy.

The Florida Defense Support Task Force, a legislatively created team established to make recommendations that protect, preserve and enhance the state's military installations and missions, unanimously and whole-heartedly supports the Department of Economic Opportunity's (DEO) recommendations for the implementation of SB 1784 regarding non-conservation lands providing encroachment protection for military installations.

The Florida Defense Support Task Force commends DEO Executive Director Jesse Panuncio and his staff for the timely, accurate and thorough compilation of this information which is key to this important endeavor. DEO staff has worked closely with Florida's military base commanders over the past few months in developing a comprehensive list of those properties identified by base commanders to prevent encroachment at their installations and possible compromising of their military missions.

Overall, for FY 2014 DEO has identified 64 sites at Naval, Air Force and National Guard installations totaling over 3,600 acres. The lands were prioritized and tiered based on existing land use restrictions, development on site, redevelopment potential, ownership and identified encroachment threat. The tiered rankings are provided in the DEO materials and are attached.

The buffering provided by these lands is critical to protecting the ability of our military to train effectively for combat. Without the buffering, encroachment could cause the Department of Defense to decrement the military value of Florida installations and make them vulnerable to closure.

Florida has rightly earned a reputation as the most military-friendly state in the nation. The 20 military installations and three Unified commands generate billions of dollars for our economy as well as stable, high-paying jobs for Floridians. The closure of any one of these bases or the loss of a mission would hurt Florida's economy and slow the recovery. Your Florida Defense Support Task Force strongly supports a multiyear program for the acquisition of these non-conservation properties to protect our military installations. It is strongly recommended that the Tier1 recommendations be the focus of legislative action on this topic during the 2014 legislative session.
