Defense Reinvestment Grant Program (DRG)

Program Details

Program Authority: Section 288.980(4), Florida Statutes

This program was created to support community-based activities that protect existing military installations, diversify the economy of a defense-dependent community, or develop plans that facilitate the reuse of closed or realigned military installation, such as developing and implementing strategies that will help communities support the mission of the military installation.

Activities eligible for funding: studies, presentations, analyses, plans, and modeling.

Defense Infrastructure Grant Program (DIG)

Program Details

Program Authority: Section 288.980(5), Florida Statutes

This program was created to support local infrastructure projects deemed to have a positive impact on the military value of installations within the state. Funds are used for projects that benefit both the local community and the military installation.

Activities eligible for funding include, but not limited to: encroachment, transportation and access, utilities, communications, housing, environment, and security.

Program Details

These two programs help communities:

- Support the mission of local military installations;
- Develop and implement economic diversification strategies to transition from a defense economy to a nondefense economy;
- Develop plans for the reuse of closed or realigned military installations;
- Acquire land surrounding military bases to prevent encroachment, protect the environment and ensure security;
- Build infrastructure to address issues related to transportation and access, utilities, communications and housing;

State FY 2023-2024 Application Cycle

Changes to the RFA:

- Those with more than three open DIG's or have received more than two extensions on a DIG,
 will not be eligible for funding.
- Attachments have been removed and added to the body of the RFA. They will still need to be filled out and submitted with each application.
- Letters of support are required.
- An estimated budget and spend/project timeline are required.
- Attachments, maps, letters of support and a current strategic plan are to be added as Addenda.
- Evaluation criteria has been updated to coincide with the requests in the RFA and statutory requirements.

Background

Florida's military installations and missions stretch from Pensacola to Jacksonville, through Florida's high-tech corridor to Miami and Key West. The installations and missions, long recognized as true national and state assets, contribute more than \$95 billion dollars annually to the Florida economy, as a result of salaries and services, defense industries, retirees, and federal programs. This makes defense the 3rd leading economic driver of the state's economy after tourism and agriculture. Additionally, defense-related spending accounts for more than 914,000 direct, indirect and induced jobs. The high-tech nature of the installations, missions and their defense industries has been a foundation for much of Florida's businesses involving aviation, aerospace, photonics, lasers, Cyber and modeling and simulation.

Florida's military installations and missions exist and are located to support the U.S. national security and defense efforts. Florida must support and enhance the military value of its installations and missions not only to the state and Floridians but also to the nation and all citizens. Since this strategic plan covers the next five state fiscal years (FY2021- 2025), the Florida Defense Alliance (FDA) will ensure our current military installations and missions remain with a focus on maintaining and increasing the force structure by gaining new missions or future consolidations. 

Direct Defense Spending







Total Direct Defense Spending (in millions)







Military Initiatives

HCPS is proud to serve approximately 4,600 children of active-duty military members and 8,800 military-connected students.

Eighty-eight percent of our schools have at least one military-connected student.

- MacDill Council for Educational Excellence is comprised of MacDill Air Force Base, School Board and district leadership and meets quarterly to enhance the educational experience of military-connected students
- Established a dedicated District Military Liaison position to assist families in navigating the district and building relationships with MacDill AFB.
- Initiated procedures allowing transitioning active-duty military the ability to apply for magnet and school choice programs before receiving official orders.

- The Public Schools on Military Installations Program provides funding to construct, renovate, repair, or expand public schools located on military installations to address capacity and/or facility condition deficiencies as prioritized by a Secretary of Defense approved project listing.
- The proposal is for a complete rebuild of the existing facilities to create a fully functional 135,000 Square Foot PK-8 school that is aligned with the standards and instructional programs for 21st Century Teaching, Learning, and Leading – providing a healthy, safe, and secure learning environment.
- This proposed Schedule of Spaces increases the sizes of the Classrooms, Cafeteria, Music Suite, Information (Media) Center and adds the Gym to correct the deficiencies noted in the Facilities Condition Assessment Report (FCAR).
- This project will strive to achieve Net Zero and LEED Silver, with an expected life cycle of forty-five years or more

Naval Weapons Station Earle


- Issue: Naval Weapons Station Earle waterfront pier operations vulnerable to sea level rise, recurrent flooding, and coastal storms
- Project Study Area: Monmouth County, NJ and other jurisdictions around southern Sandy Hook Bay
- Action: Installation Resilience studies with heavy focus on regional stormwater management and coastal reshoring

San Diego Region

- **Action:** Building off existing regional plans, report provides guidance to the Navy and local and regional agencies on how to better integrate climate considerations into their processes, and safeguard long-term transportation solutions by creating road maps for resilient transit corridors





Defense Community Infrastructure Pilot Program

Military Value

- 1. The current and future mission capabilities and the impact on operational readiness of the Department of Defense's total force, including the impact on joint warfighting, training, and readiness.
- 2. The availability and condition of land, facilities and associated airspace (including training areas suitable for maneuver by ground, naval, or air forces throughout a diversity of climate and terrain areas and staging areas for the use of the Armed Forces in homeland defense missions) at both existing and potential receiving locations.
- 3. The ability to accommodate contingency, mobilization, and future total force requirements at both existing and potential receiving locations to support operations and training.
- 4. The cost of operations and the manpower implications.

69 FR 6948, February 12, 2004 Final Selection Criteria

The final criteria to be used by the Department of Defense to make recommendations for the closure or realignment of military installations inside the United States under the Defense Base Closure and Realignment Act of 1990, Public Law 101–510, as amended, 10 U.S.C. 2687 note, are as follows: In selecting military installations for closure or realignment, the Department of Defense, giving priority consideration to military value.



Defense Community Infrastructure Pilot Program

- State or local governments or partnerships between ineligible/eligible entities.
- FY23 included program changes, review the Notice of Funding Opportunity carefully for changes if reapplying.
- Expanded project eligibility for:
 - Property either located off of a military installation or on property under the jurisdiction of a Military Department that is subject to a real estate agreement (including a lease or easement)
 - Supporting strategic seaports
 - Historically Black Colleges and Universities ROTC facilities

Background – PSMI Program

- May 2010: Secretary of Defense Gates participates in Town Hall at Fort Riley, Kansas
 - During this meeting, the condition and capacity of the Geary County Unified Public
 School District facilities located on Fort Riley was recognized as a problem
- July 2011: Secretary of Defense approved the "2011 Priority" List and basic program tenants including:
 - OLDCC to carry out the program and execute appropriated funds for the schools ranked as the worst
 - Program funds can supplement, but not supplant, other funds committed for the project
 - Program requires 20% matching share by the Local Educational Agency
 - OLDCC may waive part or all of the matching share with demonstrated inability to pay
 - September 2011: OLDCC published Federal Register laying out the program requirements:
 - Proposal package requirements (Federal Register included with invite letter)
 - Local Educational Agencies should target submission of a project proposal within 90 days following completion of this orientation meeting
 - April 2019: Deputy Secretary of Defense approved the "2018 Priority List"

Program Guidelines

- Schools are on this list to address serious capacity and condition deficiencies identified in 2011 & 2018 DODEA Facility Condition Assessment Reports
- Eligible project costs to correct school's capacity/condition:
 - Project administration
 - Architectural / Engineering, Design
 - Preparation of environmental documentation
 - Inspection and Testing
 - Construction
 - Equipment and Furnishings
 - Contingency Costs
 - Demolition of facilities being replaced, renovated or repaired
 - Costs for swing space, if required, to implement the project

Funds may be used to supplement other Federal or non-Federal funds, but may not be used to supplant funds previously committed to or available for the project

Program Guidelines (continued)

- Projects must be responsive to the deficiencies identified in the Facility
 Condition Assessment Report
- Projects must meet State and Local school district standards
- Projects should be designed to achieve Net-Zero Energy standards to extent practicable - upcoming panel
- We work with the Military Services to validate proposed student capacity and conformance with local education and design standards
- Projects on federal property must meet Unified Facilities Criteria
 - Leadership in Energy and Environmental Design (LEED) Silver standard (not certified)
 - Anti-Terrorism, Force Protection standards (UFC 4-010-01)
- 20% matching requirement from Local Educational Agency
 - Matching funds can come from non-Federal funds (State, local or private contributions)
 - OLDCC has the authority to skip over schools but will not do so as long as a good faith effort is being made to obtain matching funds

Program Guidelines (continued)


- DoD will hold Federal Interest in the resulting facility improvements for 30 years from the start of construction and for the expected useful life of the equipment
- Davis-Bacon Act not applicable to OLDCC program funds; however, Davis-Bacon or other prevailing wage requirements may be required as the result of other funds contributed to the project
- Build America, Buy America Act (2021) applies (no waivers)
- Buy American Act (1933) does not apply
- Demolition of the existing structure, if in the scope, must be completed before grant closeout
- Procurements documented Per 2 CFR 200 (A&E and Construction)
- Project Underruns match remains unchanged and Federal award will be reduced due to Supplantation
- Project Overruns grantee generally required to provide additional funding to complete the project
- Failure to comply with the Project Development Schedule is considered a violation of the grant agreement. Any changes to the Project Development Schedule require prior written approval from the grant officer

Program Guidelines (continued)

- Conditions for commencing ground disturbing field work
 - Local Education Agency CANNOT commence construction (disturb the ground) until National Environmental Protection Act (NEPA) requirements are met
 - Local Educational Agency must provide proof of site control prior to construction
 - 30 years+ is required to align with Federal Interest Period
- Conditions for disbursement of Federal funds
 - We accept evidence of funds availability of non-Federal share
 - Loan Proceeds, Line of Credit, Bond Revenues, Bank Balance Sheet
 - Grantee provides evidence of performance/surety bond sufficient to ensure completion of the project
 - All Federal payments are on a reimbursement basis thru the Payment Management System (HHS)
 - Federal disbursements proportional to the Federal and non-Federal amounts listed in the grant agreement

Critical Issues for DOD


- Impact of continuing resolution
 - If the Senate agrees to the House proposal, the Pentagon must operate under last year's funding levels. No new starts and cant increase funding for programs until a full-year spending deal is in place.
- Impact of Tommy Tuberville's continued hold on military nominations over DoD abortion policy—now at 8 months
 - Army Secretary Christine Wormuth warned that high-ranking military officers will leave their posts by the end of the year due to Sen. Tommy Tuberville's hold on military promotions. She cited as an example a two-star general who, while awaiting confirmation, submitted his retirement papers, citing concerns about how the job has impacted his family.
 - "We've had some people who've decided they're not just going to wait around," added Air Force Secretary Frank Kendall. "They're eligible to retire."



Congressional Action on FY24 Approps

Current Continuing Resolution expires at midnight on Friday, 17 Nov 2023

- Speaker Johnson proposed a tiered CR approach
 - Two tiered CR means four bills, including MILCON would be funded through January 19th; remaining funding, including DoD, would last through February 2nd.
 - A number of Republicans (the main protagonists are opposed) but Dems are NOT whipping against the bill.
 - Virtually every Democrat and a good chunk of Republicans need to vote for it. It's unclear if they have the votes but with Dem leadership not providing a vote recommendation that's a indication a lot of Dems will vote yes.
 - Dems are likely to vote for this CR because it's clean. Dems are afraid they'd be blamed for a shut down if they voted against this package
- Bill will technically trigger the 1% sequestration cuts but the Hill has until April to stave those off
- The chances we get a year long CR (possibly with a 1% cut) has increased beyond the 50% threshold











Congressional Action on FY24 Authorization

- Negotiations on the NDAA continue at the Staff Director and Chairman/Ranking Member level.
- They are working through some of the more politically difficult issues
- Unfortunately, it appears the Senate will not get to pass a motion to go to Conference
- As such, expect negotiations to complete this week and then expect the House and Senate to have a ping pong strategy where the House would introduce the compromise NDAA, hopefully pass it, then send to the Senate for their consideration

☐ Child Abuse and Neglect Reporting

- THIS IS NOT A DISCIPLINARY ISSUE: Federal law requires the DOD to request state reports regarding instances of child abuse and neglect involving military family members.
- States can assist military Family Advocacy Programs in providing needed support by requiring child protective services to report cases to the military at the onset of their investigations
- Need changes in state policy to allow identification and reporting.
 - Current statutes (F.S. 39.201) don't allow for identification of military children and reporting to military authorities.
 - MOUs primarily establish procedures for installation situations.

☐ Concurrent jurisdiction through retrocession

- States accepting jurisdiction over military installations for the purpose of adjudicating juvenile crimes in state family/juvenile courts.
- o DSLO SE working with Navy JAG SE to identify policy concerns
