2023 Summary

- FDVA State Veterans' Service Officers assisted more than 281,000 Veterans in providing information and counsel on earned services, benefits and support.
- State Veterans' Service Officers processed nearly 41,000 new claims on behalf of our Veterans and helped recover more than \$245 million in retroactive benefits for Florida Veterans and their families.

2023 Florida Legislative Session March 7 – May 5, 2023

Key Legislation

HB 485 (Rep. Salzman) & SB 824 (Sen. Collins)

- Creates FDVA Division of Long-Term Care
- Revises Qualifications of County & City Veteran Service Officers (CVSOs) – Cold War Veterans now eligible
- "Veterans' Adult Day Health Care of Florida Act"
- Creates Veterans Week in Florida each November



2024 Florida Legislative Session Governor's Budget Recommendation

- Budget invests \$8.9 million to support equipment & capital improvements for State Veterans' Homes.
- Budget includes \$102 million to begin construction of the ninth State Veterans' Nursing Home in Collier County.
- Budget continues \$2 million investment in Veterans Florida to assist Veterans skills-based employment, provide employers a skilled talent pipeline, & assists Veterans in creating and operating a small business.
- Increases number of FDVA Veterans' Claims Examiners
- Funds dental grant program that will enable deserving qualified Florida Veterans to receive no-cost dental care.



2024 Florida Legislative Session

Department Legislation

1) SB 174 - Veterans' Long Term Care Facilities Admissions

- Allows admission of spouses or surviving spouses into the State Veterans' Home System.
- Sponsor: Senator Burgess (House Companion HB 725 by Rep. Woodson)

2) SB 1004 - Tax Exemptions for Disabled Ex-servicemembers

- Increases property value tax exemption from \$5,000 to \$10,000 for Veterans with a 10% or higher disability rating.
- Sponsor: Senator Torres (House Companion Bill HB 727 by Rep. Amesty)



Governor's Focus on Florida's Future Budget FloridaCommerce's Investments

□ Florida Defense Support Task Force: \$3 million (same as 23-24)

□ Funds that address one or more of six designated issues: economic and product research and development, joint planning with host communities to accommodate military missions and prevent base encroachment, advocacy on the state's behalf to federal civilian and military officials, assistance to school districts in providing a smooth transition for large numbers of additional military-related students, job training and placement for military spouses in communities with large shares of active duty military personnel, or promotion of the state to military and related contractors and employers (s. 288.987(7), F.S.).

Defense Infrastructure Grant Program (DIG): \$7 million (same as 23-24)

□ Supports local infrastructure projects deemed to have a positive impact on the military value of installations within the state (s. 288.980(5), F.S.).

Military Base Protection and Defense Reinvestment Program (DRG): \$3 million (increase of \$2 million)

Provides support for community-based activities that address one of three designated issues: protection of existing military installations, diversification of a defense dependent community; or the development of plans for the reuse of a closed or realigned military installation (s. 288.980(4), F.S.).



Governor's Focus on Florida's Future Budget FloridaCommerce's Investments

□Job Growth Grant Fund (JGGF): \$100 million

□Rural Infrastructure Fund (RIF): \$25 million

State Small Business Credit Initiative (SSBCI): \$175.2 million

□(Broadband) BEAD Program: \$100 million+; Capital Projects Fund: \$99.9 million and Digital Connectivity Projects: \$13 million

□Supply Chain Capacity Matching Grants (incl. vertiport development for advanced air mobility industry): \$75 million

Law Enforcement Recruitment Bonus Payment Program: \$20 million

Technical Assistance for Small Manufacturers (FloridaMakes): \$3.5 million



Governor's Focus on Florida's Future Budget Partners' Investments

□ FDOE's Workforce Development Capitalization Grants: \$200 million

□FDOE's Recruitment bonuses for retired military veterans and retired first responders who commit to joining the teaching profession: \$10 million

General FHFC's Affordable & Workforce Housing: nearly \$400 million full funding for SAIL, SHIP, H2H

- FDVA: \$8.9 million to support equipment and capital improvements for the State Veterans' Nursing Homes; \$102 million to begin the construction of the ninth State Veterans' Nursing Home in Collier County upon federal grant approval (once this new nursing home is complete, Florida will have the most state-funded veterans' nursing homes in the nation)
- □Veterans Florida (VETS Program): \$2 million
- □Space Florida: \$23.5 million

UF's Florida Semiconductor Institute: \$80 million (FCO \$45 million; R&D \$35 million)



FloridaCommerce's 2024 Agency Bill HB 1419 (Tuck) & SB 1420 (Burgess)

- □ HB1419 (Tuck) HB 1419 has been assigned to committees including the Regulatory Reform & Economic Development Subcommittee, Infrastructure & Tourism Appropriations Subcommittee, and Commerce Committee.
- □ SB1420 (Burgess) SB 1420 has been assigned to committees, including Commerce and Tourism, Appropriations Committee on Transportation, Tourism, and Economic Development, as well as Rules.
- Create a long-term framework as, otherwise, task forces are generally regarded as being associated with a finite task by creating a permanent structure as a direct support organization to codifies the operational (e.g., administration of contracts and grant funds, use of FloridaCommerce personnel, facilities, resources) relationship between FloridaCommerce and the organization.
- Provide a clear mission, vision, values for the organization's support of Florida's military and defense industries and communities, preserve and protect military installations, assisting with the coordination of economic and workforce development efforts in military communities, assisting in the planning and research and development related to military missions, businesses, and military families, joint planning with host communities to accommodate military missions and prevent base encroachment, advocating on the state's behalf with federal civilian and military officials, assisting school districts in providing a smooth transition for large numbers of additional military related students, job training and placement for military spouses in communities with high proportions of active duty military personnel, and promotion of the state to military and related contractors and employers.

Standing Initiatives

- November 2023 Governor DeSantis announced more than \$28 million in infrastructure and workforce development awards for semiconductor related manufacturing and advanced packaging to NeoCity (Osceola County), Valencia College, Santa Fe College, Lake Technical College and Eastern Florida State College
- September 2022 Governor DeSantis announced nearly \$30 million in workforce development awards for aerospace, defense, manufacturing, cybersecurity and information technology industries to Eastern Florida State College, Daytona State College, Indian River State College, FloridaMakes, three school districts (Brevard, Indian River and St. Lucie) and corresponding local workforce boards
- Annual Veterans Workforce Summit Last year, FloridaCommerce and CareerSource also hosted the Third Annual Veterans Workforce Summit, where more than 230 attendees received training for the Jobs for Veterans State Grant Program.
- Local Workforce Development Boards connect veterans & military families to career opportunities (Veteran Navigators)
- □ Jobs for Veterans State Grant Program since 2019, more than \$44 million awarded to prepare veterans, transitioning service members and eligible spouses for meaningful careers
- □ Paychecks for Patriots veteran-focused statewide hiring event
- □ Homeowner Assistance Fund Program provided specific outreach to veteran-service organizations


FLNG MISSION SUMMARY





Ethics: Basis of Standards

Sources:

- Florida Constitution Article II, Section 8
- Chapter 112, Part III, Florida Statutes



Ethics: Financial Disclosures

- Each Board Member must file a financial disclosure in accordance with section 8 Article II of the State Constitution, section 112.3144, Florida Statutes, or section 112.3145, Florida Statutes, as applicable.
- Board Members must file Financial Disclosure Form 1 (Statement of Financial Interests) if not already required to file Form 6 (Full Disclosure).
- Filing a Financial Disclosure makes Board Members "Reporting Individuals" and also subject to:
 - Gift ban (section 112.3148, Florida Statutes);
 - Lobbying expenditure ban (section 112.3215(6)(a), Florida Statutes);
 - Prohibition on gifts from political committees (section 112.31485, Florida Statutes); and
 - Honorarium restrictions (section 112.3149, Florida Statutes)



Ethics: General Guidelines

General Guidelines:

- Public officers and employees are prohibited from soliciting or accepting anything of value, including a gift, loan, reward, promise of future employment, favor, or service, that is intended to influence the public officer's or employee's actions.
- Public officers* and employees cannot directly or indirectly purchase, rent, or lease any realty, goods, or services for the Task Force from any business entity of which the officer or employee or the officer's or employee's spouse or child is an officer, partner, director, or proprietor or in which such officer or employee or the officer's or employee's spouse or child, or any combination of them, has a material interest.
- Public officers and employees may not corruptly use or attempt to use their official positions to obtain a special privilege for themselves or others.
- Public officers* and employees cannot have or hold any employment or have a contractual relationship with any business entity that does business with the Task force.
- Public officials and employees may not disclose or use information not available to the public and obtained by reason of their public positions for personal benefit or the benefit of others.



Gifts

What is a Gift?

- Section 112.312, Florida Statutes, defines "Gift" as:
 - Something that "is accepted by a donee or by another on the donee's behalf, or that which is paid or given to another for or on behalf of a donee, directly, indirectly, or in trust for the donee's benefit or by any other means, for which equal or greater consideration is not given within 90 days."
- A gift is anything accepted by a person, or on that person's behalf, whether directly or indirectly, for that person's benefit and for which no payment is made.
- Examples:
 - Flowers/plants
 - Food/beverages
 - Dues, fees, tickets to events, lodging, or parking
 - Personal services for which a fee is normally charged
 - Payment, loan advance, or forgiveness of a debt
 - Property or the use of property, whether real, tangible, or intangible
 - Preferential rates or terms of a transaction not available to others similarly situated



Travel and Expenses

- Reimbursement must be made according to section 112.061, Florida Statutes.
- Lodging expenses may not exceed \$175/day, excluding taxes, unless participating in a group rate or at least three rates were acquired.
- Staffing and administrative expenses of the Task Force may not exceed \$250,000, including travel and per diem costs incurred by Task Force members not otherwise eligible for state reimbursement



Public Records

- Article I, § 24, Florida Constitution
 - "Every person has the right to inspect or copy any public record made or received in connection with the official business of any public body, officer, or employee of the state, or persons acting on their behalf."
- Florida's Public Records Act, Chapter 119
 - "It is the policy of this state that all state, county, and municipal records are open for personal inspection and copying by any person. Providing access to public records is a duty of each agency."



What are Public Records? The Content

Section 119.011(12), Florida Statutes, defines "public records" to include:

• All documents, papers, letters, maps, books, tapes, photographs, films, sound recordings, data processing software, or other material, regardless of the physical form, characteristics, or means of transmission, made or received pursuant to law or ordinance or in connection with the transaction of official business by any agency.

<u>Note</u>: All such materials, regardless of whether they are in final form, are open for public inspection unless the Legislature has exempted them from disclosure.



What are Public Records? The Form

- <u>Any form</u>: "[A]II documents, papers, letters, maps, books, tapes, photos, films, sound recordings, data processing software, or other material, regardless of the physical form, characteristics, or means of transmission" § 119.011, Fla. Stat.
- Includes emails, text messages, social-media posts, cocktail napkins, etc.
- <u>On any device</u>: Work or personal computer; work or personal phone, etc.
- In any location: In your work office; in the filing cabinet in your home garage, etc.



Providing Public Records

- Section 119.07(1)(a), Florida Statutes, provides that "[e]very person who has custody of a public record shall permit the record to be inspected and copied by any person desiring to do so, at any reasonable time, under reasonable conditions, and under supervision by the custodian of public records or the custodian's designee."
- The Public Records Act does not contain a specific time limit (such as 24 hours or 10 days) for compliance with public records requests.
 - The Florida Supreme Court has stated that the only delay in producing records permitted under Chapter 119, Florida Statutes, is the reasonable time allowed for the custodian to retrieve the record and redact those portions of the record the custodian asserts are exempt.



Exemptions – What can be Withheld?

- A custodian of a public record who contends that a record or part of a record is exempt from inspection must state the basis for the exemption, including the statutory citation to the exemption.
- Additionally, upon request, the custodian must state in writing and with particularity the reasons for the conclusion that the record is exempt from inspection.



Exempt vs. Confidential

Confidential:

 An agency is prohibited from releasing confidential information—often by threat of civil or criminal liability— unless by court order, consent, or statutorily-specified process.

Exempt:

 An agency is not required to release exempt information to the public but is not prohibited from doing so.



Exemptions Specific to FDSTF

- Section 288.985, Florida Statutes, provides that the following records are exempt from disclosure:
 - 1. That portion of a record which relates to strengths and weaknesses of military installations or military missions in this state relative to the selection criteria for the realignment and closure of military bases and missions under any United States Department of Defense base realignment and closure process.
 - 2. That portion of a record which relates to strengths and weaknesses of military installations or military missions in other states or territories and the vulnerability of such installations or missions to base realignment or closure under the United States Department of Defense base realignment and closure process, and any agreements or proposals to relocate or realign military units and missions from other states or territories.
 - 3. That portion of a record which relates to the state's strategy to retain its military bases during any United States Department of Defense base realignment and closure process and any agreements or proposals to relocate or realign military units and missions



Rights of the Requestor

- Requestors can remain anonymous (but this does not prohibit an agency from asking for information to help facilitate fulfilment of the request).
- Requestors are not required to give a "legitimate" reason as a condition of access or explain their purpose.
- Requests do not have to be in writing.
- Requestor can inspect (and photograph) records, receive copies of records, or both.



Under Chapter 119, Florida Statutes, FDSTF Is NOT Required To:

- Create records that do not exist (e.g., lists of information in records).
- Respond to information requests (e.g., answer questions about information in records).
- Perform research for a requestor.



Penalties

- A person who has been denied the right to inspect and/or copy public records under the Public Records Act may bring a civil action against the agency to enforce the terms of Chapter 119, Florida Statutes.
- In addition to judicial remedies, section 119.10(1)(b), Florida Statutes, provides that a public officer who knowingly violates the provisions of section 119.07(1), Florida Statutes, is subject to suspension and removal or impeachment and is guilty of a misdemeanor of the first degree, punishable by possible criminal penalties of one year in prison, or \$1,000 fine, or both.



Record Retention

 Section 119.021(2)(a), Florida Statutes, requires the Division of Library and Information Services of the Department of State to adopt rules establishing retention schedules and a disposal process for public records.

 \odot Each agency must comply with these rules.

- The approved records retention schedule for state and local governmental entities is located online at <u>https://files.floridados.gov/media/703328/gs1-sl-2020.pdf</u>
- A public record may be destroyed or otherwise disposed of only in accordance with retention schedules established by the Division of Library and Information Services.



Florida Government in the Sunshine Law

<u>Law:</u>

• Florida's Sunshine Law is found in Article I, Section 24 of the Florida Constitution, and Chapter 286, Florida Statutes.

Applicability:

 The law applies to ANY meeting of 2 or more members, or members elect, of a board or commission who meet to discuss a matter which will foreseeably come before the board or commission.

Sunshine Law

General Principle:

• Florida's Government in the Sunshine Law, section 286.011, Florida Statutes, commonly referred to as the Sunshine Law, provides a right of access to governmental proceedings of public boards or commissions at both the state and local levels.

Three Basic Requirements of Section 286.011, Florida Statutes:

- 1. Meetings of public boards or commissions must be open to the public;
- 2. Reasonable notice of such meetings must be given; and
- 3. Minutes of the meetings must be taken and promptly recorded.



Sunshine Law and Accessibility

Accessibility:

- Meetings must be open to the public, accessible to individuals with disabilities, and held at locations that are easy to reach and do not discriminate on the basis of sex, age, race, creed, color, origin, or economic status, or otherwise unreasonably restrict public access.
- Minutes of the meetings must be taken, promptly recorded, and open to public inspection.



Sunshine Law Exemptions

- Exemptions must be provided for in law, and the law must specify the public necessity justifying the exemption.
- The exemption can not be broader than necessary to accomplish the stated purpose of the law.



Sunshine Law Exemptions Specific to FDSTF

Section 288.985(2)(a), Florida Statutes, provides:

"Meetings or portions of meetings of the Florida Defense Support Task Force, or a workgroup of the task force, at which records are presented or discussed that are exempt under subsection (1) are exempt from s. 286.011 and s. 24(b), Art. I of the State Constitution."



Penalties for Violating the Sunshine Law

Criminal and Civil Penalties:

- Knowing violations of the Sunshine Law can result in 2nd degree misdemeanor charges with penalties up to 60 days in jail and up to a \$500 fine.
- Violations of the Sunshine Law that are NOT "knowing" violations are non-criminal and are punishable by a fine of up to \$500.
- Circuit Courts may issue injunctions to enforce the law.
- Reasonable attorney's fees can be assessed against the Board for a Sunshine violation.



Voting

- In accordance with section 288.987(3)(d), Florida Statutes, legislative members serving on the Task Force may participate in all Task Force activities but may only vote on matters that are advisory.
- The Secretary of FloridaCommerce, or his or her designee, serves as the ex officio, nonvoting executive director of the Task Force.
- A member who is present at a meeting may not abstain from voting unless there is or appears to be a possible conflict of interest under section 112.311, 112.313, or 112.3143, Florida Statutes, or additional or more stringent standards of conduct, if any, adopted pursuant to section 112.326, Florida Statutes.



Voting Conflicts

- A Board member may not vote on any matter that the Board member knows would inure to his or her special private gain or loss.
- A Board member must disclose the nature of conflict by filing FORM 8A (Memorandum of Voting Conflict for State Officers) with person taking meeting minutes.
- FORM 8A should be filed before the vote at the meeting and incorporated into the meeting minutes.
- If it's not possible to file FORM 8A before the vote, then FORM 8A must be filed no later than 15 days after the vote with the person responsible for recording the minutes of the meeting.





- From FY13-14 through FY23-24 the program has awarded @ \$19.9m in Grants



FDSTF Grant Program

- Supports military communities by funding selected projects that:
 - Directly support preserving, protecting or enhancing the installation

• **Challenge:** Anecdotally, over 4,000 organizations directly and indirectly support and interact with the military community reside in our 8-county region. About Camp Blanding Joint Training Center

Camp Blanding Joint Training Center (CBJTC) is a critically vital training center that annually trains over 350,000 Florida National Guard troops, active duty military, law enforcement officers, Department of Homeland Security agents, Drug Enforcement Agents, Florida Department of Law Enforcement agents, various Florida counties' sheriff's department personnel and first responders, and others.

The development pressure from the surrounding area has prompted CBJTC to make the areas along the border of the installation the highest priority for protection from development encroachment.

This project will purchase fee and/or less than fee interest in property(ies) within the approved Army Compatible Use Buffer (ACUB) around CBJTC by using matching funds from the FDSTF and the DoD REPI Program.

The property(ies) will be located within either Bradford County or Clay County.

The buffer will serve as protection from future development-related land-use impacts to the military installation as well as establishing an expanded buffer around CBJTC that will prevents strained relations with nearby residents thus improving the military-friendly environment in Clay County.

The buffer would also facilitate training capability growth within the current boundaries of the installation, as well as protect and safeguard current and future training operations at Camp Blanding.

An additional benefit provided by a permanent buffer area adjacent to the border of the installation is that it protects natural wetlands and state-listed flora and fauna from development activities.

This project will leverage approximately \$2,000,000 of Readiness and Environmental Protection Integration (DoD-REPI) funds. The specifics of the sale including the appraisals and contract negotiations will be handled by ACUB partner(s).

ACUB partner(s) will utilize the parcel(s) for flood mitigation and water recharge issues in this region. For properties located in Bradford County, there will be an annual payment in lieu of taxes.

The property(ies) are not included in the current Florida Forever Program and would be acquired by ACUB partner(s) as project lands or other protected lands.

Alignment With FDSTF's Strategic Plan

This project directly supports the FDSTF mission, as described in F.S. 288.987, by preserving, protecting, and enhancing Florida's military installations and to improve the states military friendly environment for service members that bring military and base related jobs to the state.

This project aligns with the FDSTF's guiding principles (goals) as identified in the FDSTF Strategic Plan, to identify, prioritize and address all current or potential base and range encroachment issues, including, but not limited to airspace, environmental, energy, frequency spectrum, and land and water use compatibility.

Finally, the FDSTF Strategic Plan long-term strategic goals for all military installations are addressed by:



- Navy Expeditionary Logistics Support Group (NAVELSG) force design has altered the traditional model for NCHBs. All basic cargo training is conducted at Naval Weapons Station Yorktown Cheatham Annex (NWSY-CAX) through battalion Unit Level Training (ULT) events.
- In support of the transition to the "Team" concept, NAVELSG units train and are assessed at the battalion company-level by capability. This requires advanced training via reps & sets in order to obtain proficiency.

- JSWTR provides the participants with timely and accurate feedback of performance and the ability to rapidly reconstruct the training event that contributes to the quality of this complex training.









Jacksonville Shallow Water ASW Training Range (JSWTR)
