#### Overall Objective: Conduct Annual Client Satisfaction Survey

- The goal of the study was to conduct a Customer Satisfaction Survey that assesses Enterprise Florida's performance from year to year.
- Enterprise Florida, Inc. (EFI) is required by law, F.S. 288.906(g), to conduct an annual customer satisfaction survey of its Florida business clients. The survey must be conducted by an outside firm with survey experience, and the names of the respondents are not given to EFI.
- Two groups of Enterprise Florida clients were surveyed: Business
  Development Clients and International Trade Clients. Based on
  their records, all clients had received services from EFI in the
  2021-2022 fiscal year; either in developing a project with new
  jobs, or in increasing international sales of goods or services.

#### Research Process: Online Survey Methodology

- Enterprise Florida sent an initial email to all clients letting them know C3Research would be conducting a survey on their behalf as their research partner.
- C3Research developed, programmed, and hosted the survey on our own servers.
- Enterprise Florida provided C3Research the respective lists of Business Development and International Trade Clients' email addresses. Upon receiving these lists, C3Research sent out the survey invitations via email to all contacts.
- C3Research worked together along with Enterprise Florida to follow-up with non-responsive clients, sending four reminder emails, to ultimately achieve an overall response rate of 31% surpassing the necessary response rate of 25%.



#### **Business Development Clients**

- 100% of the Business Development Clients (N=27) indicate they are **Satisfied** with the overall service they received, by rating them as a **6** or higher on the 10-point scale.
- **96.7% are Very Satisfied**, rating them as a 9 or 10 on the 10-point scale.
- The Business Development Clients also rated their satisfaction with the following specific business development services they received (if applicable). The following are satisfaction percentages for rating of 6 or higher on the 10-point scale:
  - 93% are satisfied with "Responses to questions and inquiries"
  - 93% are satisfied with "Working with your company and local partners"
  - 93% are satisfied with "Incentives application and approval"

#### **International Trade Clients**

- 99% of the International Trade Clients (N=84) indicate they are **Satisfied** with the overall services provided, by rating them as a **6** or higher on the 10-point scale.
- 95% are Very Satisfied overall, giving a rating of 9 or 10.
- 95% of the International Trade Clients indicate they are Very Likely to Recommend Enterprise Florida to Others by providing a rating of 9 or 10 on the 10-point likelihood scale. The calculated Net Promoter Score is 94%.
- 2022 is the twenty first consecutive year of very high ratings from International Trade clients.



### OVERALL SATISFACTION (N=111)


■ Very Satisfied (9-10) ■ Satisfied (6-8) ■ Not Satisfied (1-5)


### BUSINESS DEVELOPMENT: OVERALL SATISFACTION TREND








### BUSINESS DEVELOPMENT SPECIFIC AREAS N=27

- Working with your company and local partners





# INTERNATIONAL TRADE: OVERALL SATISFACTION N=84



The **Net Promoter Score** is calculated by taking the percentage of Promoters (those who rate the likelihood of recommending as a 9 or 10) and subtracting the percentage of Detractors (those who rate it a 6 or below).

**95%** of the International Trade Clients are Promoters, indicating they are **Very Likely to Recommend Enterprise Florida to Others** by providing a rating of 9 or 10 on the 10-point likelihood scale.

The calculated **Net Promoter Score is 94%**, which is a very good NPS rating in general.

- The EFI Rural Expansion Toolkit grants have been very beneficial to the 14-county North Florida Economic Development Partnership (NFEDP) region, and I commend the program manager and her new assistant for management of the tremendous workload all of these grants have brought. It might be a positive thing if Michelle had additional staff due to her travel duties for EFI Stakeholders, regional outreach and many other marketing activities. For the NFEDP region alone, conceivably 43 grants could be applied for, reviewed, approved, grant agreement preparation and coordination, and review and approval of deliverables and reimbursements, and issuance of reimbursement payments. There are 18 other rural counties that theoretically could also apply for 3 grants each with equal 54 additional grants. The NFEDP counties are distressed financially and it would be beneficial if their reimbursements were received quickly.
- The EFI staff is always diligent is responding to our questions and inquiries. They want to know how they can help and provide support to our rural economic developers in their venture to create jobs in Florida.
